Rules

LIMITATIONS ON ELIGIBILITY/AVAILABILITY OF PROMOTION

This promotion is void where prohibited by applicable law. The promotion is open and offered only to legal residents of the 50 United States and the District of Columbia age 18 or older. Winners may be required to sign an Affidavit of Eligibility as a condition to the delivery of the applicable prize. Employees (and their immediate families or household members) of Bristol County Savings Bank and their subsidiaries or affiliates are not eligible to enter the promotion. Each participant is limited to one entry per day.

HOW TO ENTER

No purchase is necessary to participate in the promotion. To enter, you must provide all required information requested on the entry form which is available at the County Street office of Bristol County Savings Bank located at 851 County Street, Taunton MA. Entries must be submitted to our County Street office in person. No photocopies will be accepted. Box 4002, Taunton MA 02780. By entering the promotion, you stipulate that the information you provide is accurate and may be used to contact you. The raffle will begin at approximately 9 AM (EST) on July 31, 2017 and end at approximately 4 PM on October 31, 2017. By participating, all entrants agree to abide by these Official Rules.

PRIZE

SELECTION

Winners must claim their prize within five (5) business days after the date of notification of such prize. A promotion winner's failure to respond to the prize notification within the specified five (5) business days will be considered such raffle winner's forfeiture of the prize and an alternate winner may be selected from the pool of eligible entries. If an entrant is found to be ineligible, an alternate winner may also be selected from the pool of eligible entries.
